

# Magisterial District Judge Candidate Questionnaire

The ACLU of Pennsylvania's Campaign for Smart Justice announced its Allegheny County launch in June of 2018. Since that time, a coalition of community-based justice organizations and ACLU-PA has been working to educate and engage elected officials, voters, and other stakeholders in the criminal legal system and its impact on issues such as pretrial detention and debtor's prisons, as well as substance use disorder and evictions - issues which disproportionately impact Black and brown Pennsylvanians in Allegheny County and across the commonwealth.

The following 18 questions address issues and practices that would be under your authority if you are elected/re-elected to the position of Magisterial District Judge.

## Questions

Bail

The Pennsylvania Constitution and Rules of Criminal Procedure delineate a thorough and rigorous procedure for setting bail. Please answer the following about how you will proceed with setting bail if elected Magisterial District Judge and entrusted with the power to set bail.

1) If elected Magisterial District Judge, prior to setting any condition of bail, will you conduct a careful, individualized hearing and look at all of the factors listed in the Rules of Criminal Procedure (523), which include a person's employment status and community ties? I am not in favor of cash bail. I believe decisions are to be made holistically, especially when ruling on things that can significantly affect a person's life. Our courts need more person-centered dynamics. A core principle of being person-centered is considering the full experience of an individual.

2) If elected Magisterial District Judge, will you set bail based on a person's charge alone?

Explain:

Understanding a situation should be priority. We have to remember that people are innocent until proven guilty. Monetary bail should not be a first option if a person is not dangerous.

I intend to consider the person's circumstances in any decision I make. I have a serious interest in not punishing poverty or marginalized communities, which have been disproportionately affect by things like monetary bail.

#### Fines & Costs

Substance Use Disorder

14)Do you think incarceration is a form of treatment for individuals with substance use disorder?

Those who struggle with addiction should be helped through restorative means. I have worked as a drug and alcohol therapist so I understand how complex the circumstances can be. I see the MDJ position as an opportunity to provide accessibility to programs and resources for those who struggle with these issues. I plan to make our court prioritize alternatives rather than incarceration and costs.

15)Do you believe substance use disorder is a mental health disorder (as it is recognized by the American Psychiatric Association in the DSM-V) and must be taken into consideration when handling criminal cases?

I respect the DSM-V and have a significant amount of experience with it. Although we recognize substance use disorder as a mental illness, I have found it more useful to ask the individual how they define their experience.
