NEW STAFFER: MATT STROUD

2015-2016 ACLU-PA HIGHLIGHTS:

LEGAL

- In J.H. v Dallas, the ACLU of Pennsylvania won a settlement with the PA Department of Human Services that will drastically reduce the wait times for treatment for criminal defendants with severe mental illnesses. These individuals, who have been declared incompetent to stand trial, have been languishing for upwards of a year in jail due to a scarcity of available beds at Pennsylvania state hospitals
- In a major blow struck for indigent defense, the Pennsylvania Supreme Court ruled in Kuren v. Luzerne County that poor defendants in Pennsylvania have the right to challenge their inadequate legal representation prior to conviction. This means that in counties that fail to provide proper funding for indigent defense, defendants will be able to use the courts to try to compel their county to provide adequate funding for their public defender's office.

LEGISLATIVE & ADVOCACY

- ACLU-PA strongly supported the Wolf administration's move to implement online voter registration in 2015. Nearly 900,000 people used the online registration tool in 2015-2016, over 500,000 of whom were newly registered voters.
- Even though the ruling in our 2014 case, Galarza v. Szalcyk, made it clear that municipalities would incur heavy potential liabilities by collaborating with Immigrations and Customs Enforcement (ICE) to detain suspected undocumented immigrants, a bill was introduced in the PA legislature that would penalize so-called "sanctuary cities" for non-cooperation. We strongly opposed this bill, which did not pass in 2016.
