

- 1) As a magisterial district judge I am required to apply the law, including the Pennsylvania Rules of Criminal Procedure, in all cases that come before me. Under the ethical Canons that apply to judicial conduct, I am unable to make pledges or promises that are inconsistent with the impartial performance of my judicial duties.

18) *District Judges are elected locally partly so that local community values are incorporated into their decisions. The ethical Canons that apply to judicial conduct require judges to apply the law fairly and impartially, without being swayed by public clamor or fear of criticism.
