Dear Mr. Skumanick:

I am writing in response to your March 5 letter, which, in relevant part, denied our request for a copy of the two photos showing our clients because to transmit them "would be a violation of the Federal Statute." Based on your own description of the photos, however, they are not illegal under federal law.

The federal child pornography statute applies only to "sexually explicit conduct" or "lewd exhibition of the genitals or pubic area." See 18 U.S.C. § 2256. Neither photo, according to your description, meets this definition. The one of Marissa and Grace depicts them from the waist up, wearing just bras. The one of Nicole shows her breasts, but not genitalia or pubic area, which are covered by an opaque towel. Accordingly, I am renewing my request that you transmit to me a copy of the two photographs.

I am also writing to confirm the position you took during the March 3 telephone conversation that included my staff attorney, Sara Rose, and me. You advised us that you believed you could charge each of the girls under 18 Pa.C.S. § 6312(d), for possession of child pornography. You asserted that because the girls apparently consented to being photographed they could be charged as accomplices. You also indicated that you could charge them under 18 Pa.C.S. § 7512, which governs Criminal Use of a Communication Facility. Finally, you indicated that they could be charged under the open lewdness statute, 18 Pa.C.S. § 5901.

You also indicated during the call that you had not reconsidered your intention to proceed with charges if the girls refused the informal adjustment that has been offered, and apparently accepted, by the approximately seventeen other minors. Under that informal adjustment, our clients would have to pay \$100 to participate in a five-week, two hours per week, course. You indicated that you would be willing to

waive the fee for Miller and Kelly, but not Charney. You were kind enough to fax the outline of that course in a seven-page fax transmitted on March 5. Additionally, if our clients accepted the informal adjustment they would be on probation for at least 6 months and would during that time be subjected to random drug tests.

If I have misrepresented the current status of our discussion, please accept my apologies. Please also let me know as soon as possible what it is we have misunderstood. If I do not hear from you I will assume that the foregoing description accurately reflects your position.

We expect to complete our research this weekend and will respond to your demands next week.
