



OFFICIAL NOTICE

The Department of Transportation now requires verification of an individual's Social Security number for all learner permits, driver licenses and identification documents we issue. This verification is done by comparing the Social Security number you provided the Department to the Social Security number that is on record for you with the Social Security Administration. We have not been able to verify with the Social Security Administration the Social Security number you provided when you applied for your learner permit, driver license or identification card.

As a result, your driving privilege is being cancelled effective June 19, 2009 at 12:01 a.m. as authorized by Section 1572 of the Vehicle Code.

In order to obtain reconsideration of this cancellation, you must take the following identity documents to a Driver's License Center prior to June 19, 2009. If the Department is unable to verify your name, date of birth, and Social Security_number with the Social Security Administration, your driver's license/identification card will be cancelled indefinitely until this matter is resolved. A listing of all Driver License Centers and their hours of operation is enclosed for your review.

U.S. Citizens -	Non-U.S. Citizens - You must bring all of the following:
Social Security Card (card cannot be laminated) and one of the following: • Birth Certificate with raised seal (U.S. issued by an authorized government agency, including U.S. territories or Puerto Rico. Non-U.S. Birth Certificates will not be accepted) • Certificate of U.S. Citizenship (BCIS/INS Form N-560) • Certificate of Naturalization (BCIS/INS Form N-550 or N-570) • Valid U.S. Passport NOTE: Only valid Passports and original documents will be accepted. Social Security Card Valid Passport All original BCIS/INS documents Written verification of attendance from school (Student Status Only) Written verification from employer (Employment Status Only) To obtain detailed information regarding "identity/residency requirements", you can visit www.dmy.state.pa.us, click on "Identity/Security" then click on "Documents needed for proof of identity and residency".

THIS IS A FINAL ORDER OF CANCELLATION. If your Social Security number cannot be verified with the Social Security Administration by June 19, 2009, you are required to return your license to the Department. If you do not have a license to return, you must complete and submit form DL-16LC or a sworn affidavit stating you are aware of the sanction against your driving privilege. Failure to comply shall result in the Department referring this matter to the Pennsylvania State Police for prosecution under SECTION 1571(a)(4) of the Vehicle Code.

You have the right to appeal this action to the Court of Common Pleas (Civil Division) of the county of your residence within thirty (30) days of the mail date of this letter. If you file an appeal in the County Court, the Court will give you a time-stamped certified copy of the appeal. Send this time-stamped certified copy of the appeal to:
