# **Medical Necessity of Transition-Related Health Care**

House Bill 1933 proposes a ban on transition-related coverage that is regressive and out of step with the medical, legal, and national consensus on health care. Every major medical organization, and an overwhelming consensus of medical experts, agree that medical treatment for gender dysphoria, including surgical procedures, are effective, safe, and medically necessary. In keeping with this consensus and contemporary standards of care, Medicare, Medicaid, and private insurance policies across the country routinely cover transition-related care as medically necessary treatment.
