

Magisterial District Judge Candidate Questionnaire

The ACLU of Pennsylvania's Campaign for Smart Justice announced its Allegheny County launch in June of 2018. Since that time, a coalition of community-based justice organizations and ACLU-PA has been working to educate and engage elected officials, voters, and other stakeholders in the criminal legal system and its impact on issues such as pretrial detention and debtor's prisons, as well as substance use disorder and evictions - issues which disproportionately impact Black and brown Pennsylvanians in Allegheny County and across the commonwealth.

The following 18 questions address issues and practices that would be under your authority if you are elected/re-elected to the position of Magisterial District Judge.

Questions

Bail

The Pennsylvania Constitution and Rules of Criminal Procedure delineate a thorough and rigorous procedure for setting bail. Please answer the following about how you will proceed with setting bail if elected Magisterial District Judge and entrusted with the power to set bail.

 If elected Magisterial District Judge, prior to setting any condition of bail, will you conduct a careful, individualized hearing and look at all of the factors listed in the Rules of Criminal Procedure (523), which include a person's employment status and community ties? Factors such as employment, family situation, housing status, and community ties will be critical in the decision-making process when considering setting bail. As the purpose of bail is to ensure the defendant's appearance at court, not to punish anyone before they are convicted due to socioeconomic status, I will be very careful in considering each case that would come before me.

2) If elected Magisterial District Judge, will you set bail based on a person's charge alone?

Explain:

Racially Discriminatory Practices

6) Do you believe racial discrimination in Pennsylvania's criminal legal system is an issue?

Explain:

In Pittsburgh, Black residents make up only 23.2% of the population, yet they experienced 44% of all traffic stops, 71% of frisks, 69% of all warrantless searches and seizures, and 63% of arrests conducted by the Pittsburgh Police. Additionally, while the population of Allegheny County is less than 13% Black, the population of Allegheny County Jail is 67% Black.

7) If elected to the position of Magisterial District Judge, will you work towards making sure you aren't deciding cases in a way that is discriminatory towards black and brown communities?

Explain:

Answering this question falls under making a pledge as to how I would rule in certain cases and could be seen as prejudging a case. However, I do find it prudent to mention that I have been working hard to educate myself on the experiences of Black Americans in the criminal legal system, as well as the ways that our society has enforced and codified principles of white supremacist and racist ideology into our legislation and culture. This is a lifelong process of unlearning and I will constantly be working to know better and to do better.

Fines & Costs

8) If elected Magisterial District Judge, will you comply with the requirements in the relevant statutes (42 Pa.C.S.§ 9726(c) and (d)) for setting discretionary fines, and will you consider a defendant's financial resources when imposing such fines?

(42 Pa.C.S.§ 9726(c)) clearly states that a fine can only be assigned if the defendant is able to and will pay the fine, while (42 Pa.C.S.§ 9726(d)) requires the court to consider the finances and financial burden of the defendant. I will adhere to these requirements.

9) If elected Magisterial District Judge, in cases in which you cannot immediately hold a payment determination hearing pursuant to the Rules of Criminal Procedure (456) (, will you schedule a new hearing and determine if a defendant can be released on their recognizance without requiring collateral?

Justice should not be about revenge, nor should there be an automatic assumption of bad faith. Setting these payment determination hearings ensures people will be given ample opportunity and flexibility so that we can achieve restorative as opposed to punitive justice.

Evictions

While I can not answer this question as stated as per the rules of the Magisterial Code of Conduct, which forbids promising a specific ruling on a case, I will adhere to the federal, state, and local eviction moratoriums, recognizing that becoming unhoused poses a more severe public health risk than usual. Unhoused people seeking shelter causes an increase in crowded conditions, which puts everyone involved at risk of COVID-19 infection.
